# PENISTONE TOWN COUNCIL

Minutes of the Ordinary Town Council Meeting held on Monday November 21<sup>st</sup> 2011 in the Council Chamber, Town Hall, Penistone.

Present: The Town Mayor Cllr. Webber, in the Chair, Cllrs. Barron, Cutts, Ms. Green, Hand – Davis, Hinchliff, Mrs. Hinchliff, Marsh, Millner, Starling and Unsworth.

Before opening the meeting the Town Mayor allowed ten minutes public participation.

## Apologies for absence -

Cllrs. Mrs. Rusby, Pilkington, Chapman and Mrs. Webber

**RESOLVED** the apologies are accepted.

### 2. Declarations of Personal or Prejudicial Interest

The **Town Mayor** invited declarations of which Cllrs. Marsh and Unsworth declared interests in item 8 (National School) and Cllr. Marsh declared an interest in item 12 (public toilets) and 15 (allotments on Berrywell Ave)

**RESOLVED** that the declarations are recorded

## 3. Approval of Minutes.

The Minutes of the following meetings were **approved** a true record and signed by the Mayor accordingly,

## 4. Reports from Elected Members of Barnsley M.B.C.

**Cllr.Millner** alluded to the following in his report:

Penistone Skate Park: The power problem had now been resolved, and expenditure for new lighting had been improved which was anti-vandal proof.

Green Park: The children from St. Johns school had been given the task of choosing the new name for the development and had decided on "The Buckingham". Some members voiced concerns that the development appeared to be slow in construction however **Cllr. Millner** assured those concerned that this was not the case, and that the building works were in an advanced state.

Cllr. Hand – Davis reported that the relevant scrutiny committee would be meeting imminently to discuss a snow plan should it be necessary and that extra salt had been purchased for the Penistone area.

The area transport partnership is to investigate the lack of railway carriages on the Penistone Line as only one was in operation.

**Cllr. Mrs. Hinchliff** reminded members that there are actually two carriages with a view to providing three.

**Cllr. Unsworth** asked if the local shopkeepers could be persuaded not to sell eggs and flour on mischievous night as there had been reports of cars and windows being pelted! **Cllr. Hand** – **Davis** agreed to raise the matter at the next PACT meeting.

**Cllr. Barron** raised the matter of the resurfacing of estate roads and the A628 only being partly resurfaced (from Thurlstone to Millhouse Green) with the assurances of the entire section was being carried out.

However the **Town Clerk** reported the theft of winter plants from the Community Centre and that due to financial restraints Neighbourhood Pride would not be carrying out the service of planting the tubs within the grounds of the Community Centre in future. The **Town Clerk** informed members that the tubs would remain should the Town Council wish to plant them or Neighbourhood Pride would carry out the service on a rechargeable basis. The **Town Clerk** was asked to obtain the cost of the service and report to the meeting in December.

#### 8. Resource Centre.

The **Town Clerk** reported that the drainage system had again been blocked by users of the centre and the cleaning had been carried out on a rechargeable basis and informed again of their responsibilities.
