#### **PUBLIC OUESTION TIME**

Comments and Suggestions from the Electorate of Penistone on Matters relating to Penistone Town Council

Q Could the bus timetables be reviewed, as the last bus to Silkstone is via Hoylandswaine and not Oxspring and Thurgoland?

**Cllr. Unsworth** agreed to investigate with the Rural Transport Partnership.

Q What is happening with the community grants from the wind farm companies and could a policy be drafted on future applications for wind farms

Cllr. Mrs. Rusby agreed to investigate the grant funding however was aware a grant of £1,000.00 had been donated to the model aircraft club.

**Cllr. Pilkington** added that as part of planning determination the Town Council is unfortunately not the planning authority Barnsley MBC, is and that the Town Council can only register its objections or comments.

**Clir. Mrs. Rusby** also added that a delegation of members of the Planning Regulatory Board have seen how the turbines have blighted the area. However it is central government policy that is pushing for renewable energy.

He also agreed to the disabled parking bay outside the Spar supermarket reinstated

## Q. The square about and one way system is totally inadequate.

**Cllr. Starling** replied that he has met representatives from the Highways Division within Barnsley MBC and it has admitted there are problems, and has agreed to re site the No Entry Sign, replace the road markings and the possibility of providing a physical barrier outside HCBC Bank.

## Q. Vehicles are using the pedestrian access on Back Lane to the market

**Cllr. Pilkington** replied that the Town Council is still objecting to the plans for this use in conjunction with phase three of the proposed Bridge Street development.

# Q. Will there be any items of children's play equipment erected on the field following the completion of the allotments.

**Cllr. Pilkington** replied that it was not the intention of Barnsley MBC which owns the land to provide any play equipment, however this would be investigated with the Authority.

There being no further questions the members of the public expressed their customary vote of thanks to the Town Council for the work that they carry out.
