# PENISTONE TOWN COUNCIL

Minutes of the Ordinary Town Council Meeting held on Monday March 17<sup>th</sup> 2014 in the Council Chamber, Town Hall Shrewsbury Rd. Penistone

Centenary Celebrations the Paramount is planning a year of centenary celebrations encompassing the opening of the Town Hall and Assembly Rooms which opened in October 1914 and the Cinema opening in November 1915 and staff would be pleased to receive any information from anyone who remembers the Carnegie gift.
