PENISTONE TOWN COUNCIL

Minutes of the Ordinary Town Council Meeting held on March 16th 2015 in the Council Chamber, Town Hall, Shrewsbury Rd, Penistone

Present: The Mayor Cllr. Marsh, in the chair, Cllrs. Barron, Cutts, Hand – Davis, Hinchliff, Mrs. Hinchliff, Millner, Mrs. Rusby, Steel, Webber

Also present the Acting Town Clerk, Amanda Hart, Paula Tweed and Matthew Smith from BMBC Policy Management & Development respectively, the public and press.

The **Town Mayor** introduced Paula Tweed and Matthew Smith who respectively gave presentations addressing questions put to them previously by the Town Clerk on behalf of Penistone Town council. These covered aspects of the Local Development Plan and of Neighbourhood Plans and of the planning process. The councillors then were able to ask questions and raise various points of interest and concern all of which were answered at length by the officers from BMBC. There then followed a discussion on various aspects of Section 106 and affordable housing.

The **Town Mayor** thanked Paula Tweed and Matthew Smith for their attendance and then offered ten minutes public participation prior to the meeting proper. Questions asked were:

- 1. Brownfield site development a Freedom of Information request had revealed BMBC had 80 acres of such land and that the amount held by the Coal Board was unknown
- 2. Development proposed around Wellhouse Lane and the surrounding area was an example of 'aggressive planning'.
- 3. Pedestrian access for the Hartcliff development the road leading in is too narrow for pavements.
- 4. Affordable housing is not always going to local people.

There being no further questions the **Town Mayor** told the meeting that Ed Elliot was leaving the Barnsley Chronicle, he would be missed and all present wished him well for the future. The **Town Mayor** then opened the meeting proper.

4. Reports from Elected Members of Barnsley M.B.C.

Cllr. Hand – **Davis** reported he had no contact from BMBC over the problem of the infrastructure within Penistone, there has been a changeover of staff in Highways but he will keep pressing for answers. That there will be development is irresistible and the provision of affordable housing is a complex issue with criteria having been changed..

Cllr. Mrs. Rusby agreed with Cllr. Hand-Davis's comments and made the point that affordable housing is not the same as social housing. The demand for executive housing is due to the area being desirable to live in;in turn this will bring business to Barnsley. **Cllr. Webber** commented that the BMBC core strategy states that affordable housing is needed in the west of the borough so there is a long established need. However there has to be free land and developers to build.

Cllr. Barron raised the question of provision of defibrillators, there followed discussion re financing and placement at it was agreed to defer the matter to the next meeting.

The **Town Mayor** thanked the members for their reports.

A vote was taken on whether to register with BMBC to designate a neighbourhood area as an initial step – **CARRIED** with **Cllr. Barron** objecting. **Cllr. Webber** volunteered to do this in the absence of the Town Clerk
