PENISTONE TOWN COUNCIL

Minutes of the Ordinary Town Council Meeting held on April 18th 2015 in the Council Chamber, Town Hall, Shrewsbury Rd, Penistone

Also present the Acting Town Clerk, Amanda Hart, the public and press.

The Town Mayor offered ten minutes public participation prior to the meeting proper. Concern was voiced with regard to the Community Action Group's efforts to restart the Fur and Feather market as it was considered by some to be both unhygienic and cruel. Councillors commented on the problems of parking, the necessity for cages to be DEFRA compliant and the storage of these.

1. Apologies for absence – Apologies were received from **Cllrs. Pilkington, Webber, Mrs Webber**

RESOLVED the apologies were accepted.

2. Declarations of Personal or Prejudicial Interest

4. Reports from Elected Members of Barnsley M.B.C.

Cllr. Unsworth commented on the Countryside Skills event held at High Hoyland on Easter Saturday which was very interesting and included drystone walling. He also commented on the impressive presentation given at the Area Council meeting by Millhouse Green School on the problem of speeding on the A628 and road safety. **Cllr. Marsh** told how the BMBC Ward Councillors had tried before to get action on this but no action was taken by BMBC.

Cllr. Hand – Davis reported that the problem of litter in Penistone was getting worse. He mentioned that the quota of affordable housing for new developments could now be up to 30%. He had also had had complaints about the quality of the bus service provided by Tates, these included buses breaking down and people being left stranded.

We must keep pressing for a fair share to be built in Penistone not elsewhere. She emphasized the potential danger at Millhouse Green School due to speeding traffic. Councillors then commented on the problems of flytipping in the area, the speed of HGVs and the unreliability of Tates' service.
