PENISTONE TOWN COUNCIL

Minutes of the Ordinary Town Council Meeting held on June 15th 2015 in the Council Chamber, Town Hall, Shrewsbury Rd, Penistone

Also present the Town Clerk K. Coulton, Ian McKay Leeds City Council, public and press.

The **Town Mayor** offered ten minutes public participation prior to the meeting proper. Comments from the public included:

An increase in parked cars in the vicinity of St. Johns school could road markings be provided?

Members of Community Action Penistone expressed their delight at Penistone receiving designation as a neighborhood area by Barnsley MBC and this may be a chance for Penistone to be at the forefront in its development and would be willing to provide volunteer help if needed at any time.

There being no further questions the **Town Mayor** introduced **Ian McKay**

Mr. McKay gave a presentation on Neighbourhood Plans on why it gives communities direct power to develop a shared vision for their neighbourhood and shape the development and growth of their local area. It can decide where new homes, shops and offices are to be built and what new buildings should look like and the infrastructure what should be provided.

It can designate local green space, promote more development than set out in the Local Plan, and decide what type of development should happen in the neighbourhood.

However it cannot conflict with the strategic policies in the Local Plan prepared by the Local Authority or be used to prevent development that is included in the Local Plan. It can also make provision to set up or expand businesses, transport and access, develop schools places of worship, health facilities, youth centres and village halls. It can restrict certain types of development and change of use, protect and create open space and nature reserves, allotments, sports pitches, play areas, parks and gardens and planting of trees protect buildings and historic assets and promote renewable energy projects.

Following a brief questions and answer session the Town mayor thanked Mr. McKay for his presentation and opened the meeting proper.

4. Reports from Elected Members of Barnsley M.B.C.

Cllr.Hand – **Davis** reported on his recent meeting with the Cabinet member regarding the current infrastructure, school figures, affordable housing, roads etc. and the recent press release.

It was agreed that the Town Clerk would write to the Doctors in Penistone for its ten year vision on the town's envisaged expansion and capacity in moving forward.

Cllr. Unsworth reported on the shortages of G.P's in the NHS and the recent successful grants made by Penistone Ward Alliance to local groups.

Cllr. Millner spoke on future expansions of Thurlstone, Millhouse Green schools and Penistone Grammar School's sixth form and the fact that St. Johns school is already to increase capacity

Cllr. Webber commented that plans for school expansions may receive resident objection and the need to consult with local residents.

Cllr. Cutts referred to the obscured sight lines at the top of Green Road and the need for yellow lines near the junction, the pedestrian crossing near the Chapel and the absence of lighting in the vicinity of Buckingham House.

He also asked if an officer from the Highways Department could be invited to a future meeting to speak on how the criteria for repairs is decided.

The **Town Mayor** thanked the Ward Councillors for their reports.

6. Leisure and Amenities Report.

Cllr. Cutts reported on the following:

Staffing: We intend to employ one relief member to cover for people on holiday over the summer. This position has been advertised in the preview booklet and in the cinema itself. Candidates will be interviewed in the very near future.

Bar: We are looking into purchasing a new coffee machine when the current contract expires in July for the current machine.

Programme: Films continue to be well attended, satellite events less so however the Andre Rieu satellite concert in July is selling well. Razzamatazz Youth Musical Festival has unfortunately been cancelled due to cast withdrawing with other commitments.

Paramount Report Continued.

Building: We are currently working with AVLS on the following:

Control Package- desk upgrade, essential cabling and equipment designed to get the most from the existing lighting system. This package is designed to work with touring lighting systems and subsequently reduce "get in" times.

Communication Package – Supply a flexible six way communications system to provide discrete communication during shows, set up and rehearsals between multiple positions i.e. stage manager, curtain, sound and follow spot operators.

LED Package – Supply additional low energy multifunction theatrical LED fittings. All above have now arrived and are being installed as time permits.

Boiler – Barnsley MBC has arranged for a boiler survey to be carried out – this has resulted in it being shut down. We have been pursuing NPS about this and an officer has been out this week and has forwarded a plan to replace the boiler urgently. **Cllr. Cutts** was thanked for his report.
