**Cllr. Millner** commented on rural broadband and that 98% of locations will be covered.

There appeared to be an improvement on taxi services as officers have been enforcing new regulations

**Cllr. Cutts** referred to the traffic situation on Green Road and that the road markings had still not been implemented.

**Cllr. Hand – Davis** added that there would always be mitigation for pedestrians and would be surprised if it was reversed.
