# PENISTONE TOWN COUNCIL

Minutes of the Ordinary Town Council Meeting held on February 15<sup>th</sup> 2016 in the Council Chamber, Town Hall, Shrewsbury Rd, Penistone.

Present: The Mayor Cllr. Millner, in the chair, Cllrs. Mrs. Millner, Chadburn, Cutts, Hand – Davis, Hayler, Hinchliff, Mrs. Hinchliff, Kimberley, Marsh, Ogle, Mrs. Rusby, Unsworth and Webber.

The Town Mayor introduced Sarah Ford from Barnsley MBC's Public Rights of Way Section who gave a presentation on the proposed Royd Moor Reservoir project.

Key elements in upgrading the route which included change of use from footpath to bridleway on Royd Moor lane to Folly Lane.

Improvements to the surface of the bridleway on Ingbirchworth Lane

Natural access and habitat improvements on the informal paths around the reservoir.

Many elements of the project will include opportunities to run volunteer days for local residents to help with practical improvements and skill developments.

Yorkshire Water and Barnsley MBC are clarifying some legal elements and match funding contributions.

Although there is no intention of asking for any match funding from either Gunthwaite or Penistone Councils as half the project falls within Penistone Town Council's area, support was required to run the joint project.

Following a brief discussion it was agreed Penistone Town Council would support the project and that the Town Clerk would write to confirm the action.

The Town Mayor on behalf of the Town Council was then presented with the new certificate confirming Penistone as a Fairtrade Town by the Chairperson Margaret Unsworth.

The **Town Mayor** offered ten minutes public participation prior to the meeting proper. Comments from the public included:

Could an update be given on the progress of the public toilets and the proposed Park and Ride at the Railway Station?

Cllr. Marsh would report on the toilets as it was on the agenda.

Park and Ride. The land was under the ownership of a developer and it was presumed this scheme may be carried out should permission be approved for housing.

Could another pedestrian crossing be provided on the High Street?

Cllr. Unsworth replied that another crossing had been planned, however due to the many utility services beneath the footway at this location it was not feasible to provide another crossing.

There being no further questions the Mayor opened the meeting proper.

**Cllr. Mrs. Rusby** alluded to a recent press report in the Barnsley Chronicle that motorists had been penalized for reversing into the bus lane outside the Spar on the High Street. **Cllr. Unsworth** commented that he had not received any report of this practice.
