A schedule detailing the applications was received.

Seventeen applications were considered from Barnsley Metropolitan Borough Council. There were no objections to nine of these. In the case of applications 2022/1300 and 2022/1308-1314 the Committee unanimously agreed that the following statement of objection should be sent to BMBC Planning Officer :

"Penistone Town Council objects to the sheep sculpture applications, 2022/1300 and 2022/1308 to 2022/1314. In our view these cartoon sheep sculptures are hideous and could make Penistone a laughing stock. No consultations regarding design or suitability were made with the community and Penistone Town Council was presented with a fait accompli. We fear these virtually immovable sculptures may become covered in spray paint graffiti and we presume BMBC will be responsible for dealing with this. Children climbing on these extremely heavy sculptures may fall, and we presume BMBC will have public liability responsibility. Penistone Town Council also wishes to state the opinion that a better use could have been found for the Principal Towns funding."
